#### **The curriculum**

The Privacy Academy comprises eight modules, held monthly, facilitating deep dives into crucial areas such as leadership, incident management, and policy development. The Privacy Academy sessions follow 9ine's Data Privacy Framework; eight core modules that can be mapped to any domestic or international law in order to operationalize the principles of the law into actionable steps that, when implemented, will help an organisation to demonstrably show compliance with the law.

#### **The 9ine Platform**

#### The modules

Each module consists of 45 minutes of theoretical instruction, followed by hands-on scenario-based problem-solving and interactive Q&A sessions, making each 90-minute session both informative and engaging. Moreover, for those unable to attend live sessions, on-demand access ensures flexibility in learning.



Leadership & governance: Course covering accountability and evidencing compliance in a structured privacy programme. Includes case studies and real world examples.



**Records of Processing (ROP) & data mapping:** Course covering the practicalities for personal data inventories including common problems and pitfalls. Also included is coverage of the legal bases for processing personal data.



**Incident and breach management:** Course covering the meaning of a breach in data protection and what steps should be taken to avoid and mitigate them. Common issues and best practices for breach management are also discussed.



Data sharing, contracts & vendor management: Course covering vendor assessments and data processor due diligence. Includes handling of international personal data transfers, standard contractual clauses and data processor agreements.



Al risks & regulation: Course covering the known risks of Al, potential to create data privacy related damage and distress and developing regulation which schools will need to address.



Information security & operations: Course covering the intersection of IT security and data protection. Coverage of data protection by design and by default along with best practices for integrating privacy into Information Security assessments.



Risk management & controls: Course covering assessments and risk management, particularly Data Protection Impact Assessments (DPIAs). Other key assessments such as legitimate interest assessments and transfer impact assessments are also covered.



Policies & notices: Course covering the essential policies for data protection along with best practices for implementing those policies and procedures in a school.



#### The dates

The Privacy Academy 2024/25 cohort starts their programme in November 2024 and the workshops run monthly through until the end of May 2025. Can't attend a session? While we encourage all participants to attend live for the exercises and colleague discussions, all workshops are recorded and slides will be supplied so you can access the material on demand.
